Federal regulations require that the State Agency/OHCNP provide its sponsors with the CFDA numbers of grants administered by OHCNP and passed through to subrecipients, i.e. Sponsors/School Food Authorities. These numbers can be used to ensure proper identification, tracking and monitoring of Federal monies.
