Then, complete the attached "SY 20-21 SSO Waiver Request Form" (and the attached Excel spreadsheet, if applicable to your SFA). Any waiver requests submitted using the previous version of the form (dated 9/8/20) will not be accepted. Submit the completed document(s) via email to rachel.itano@k12.hi.us,

If your SFA previously submitted a waiver request to serve meals under the SSO during SY 2020-2021, <u>do not</u> submit another waiver request. The NSLP team is in the process of reviewing waiver requests that were previously submitted.

NOTE: the attached waiver form is specific to serving meals under the Seamless Summer Option (SSO). This means that your SFA may be able to serve meals to <u>any</u> child in the community. If your SFA would like approval to use the nationwide waivers related to the National School Lunch Program (NSLP)/School Breakfast Program (SBP) to serve your school's enrolled students, please refer to the email, "IMPORTANT REMINDER: SY 20-21 NSLP/SBP Meal Service Waiver Form" that was sent to all SFAs on October 13, 2020. If your SFA would like approval to serve meals under the Summer Food Service Program (SFSP), please email Daniel Sutcharitkul: daniel.sutcharitkul@k12.hi.us.

The waiver request must be approved by HCNP before your SFA can implement the waiver(s) and claim meals for reimbursement. We will do our best to approve your waiver request in a timely manner.
