# Current Waivers

- ▶ At-risk Afterschool Area Eligibility Waiver
- ▶ Non-Congregate Feeding
- ▶ Meal Service Times
- ▶ Meal Pattern Flexibility
- ▶ Parent/Guardian Meal Pick Up

# At-Risk Afterschool Area Eligibility

- ▶ Allows afterschool care centers, regardless of location, to serve at-risk afterschool meals and snacks



# Non-Congregate Feeding

- ▶ Allows meals to be provided outside of congregate feeding setting
  - ▶ Can be picked up at a designated site or delivered to homes




# Meal Service Times

- ▶ Allows meals to be served outside of standard meal times



# Meal Pattern Flexibility

- ▶ Waives requirement to serve meals that meet the meal pattern requirements
  - ▶ Milk
    - ▶ Unflavored low-fat milk
  - ▶ Grains
    - ▶ One serving WGR per day
    - ▶ Ounce Equivalent crediting
- ▶ Must provide sufficient reasoning

# Parent/Guardian Meal Pick Up

- ▶ Allows parent or guardian to pick up meals for children
  - ▶ Plan to ensure accountability and program integrity is required
